### MEMBERSHIP APPLICATION

The WEA Illawarra offers Membership to persons that have commenced an educational activity through the WEA and who have an interest in the development of the WEA as a provider of quality education and training services, with a focus on adult life-long learning.

#### **Vision**

WEA Illawarra aspires to be a recognised leader in the provision of quality education and other services that contribute to individual development and the well being of the community

#### **Mission**

The mission of the WEA Illawarra is to provide a diverse range of education, training and other services that promote life-long learning and enhance the social, lifestyle and employment prospects of individuals and of the community

#### **Cost**

There is no cost for membership however members should be aware of their liability in the event WEA Illawarra closes down. If the WEA is wound up during the time of their membership or within one year thereafter, members are required to contribute to the debts and liabilities of the WEA up to a maximum of five dollars (\$5) per member.

#### **Eligibility for membership**

A person, aged 18 years or over, who commences an educational activity provided by the WEA, may apply to become a Member and shall remain a Member of the WEA for a period of twelve (12) months from the time their membership is approved.

#### **Voting rights**

Members are entitled to vote at the Annual General Meeting and Special meetings. The constitution allows for up to six (6) Directors of the Board to be elected by the Members.

#### **Membership benefits**

Discounts may be claimed at the time a person applies for Membership however until formally notified the applicant is regarded as a temporary Member.

- Members receive 10% discounts on a range of lifestyle and non-accredited courses
- Members receive Last Minute special offers on certain courses
- Members receive the 4<sup>th</sup> person free when enrolling 4 people in the same course
- Members have the right to vote for up to 6 Directors of the Board
- Members can contribute to the development of the WEA via the WEA Advisory Body
